This is recommended to avoid an additional service call for minor issues that are repairable at the time of the opening.

**Pool openings:** Must have access to your yard and pool, power to the equipment, a working electrical outlet and a water spigot with a garden hose attached. Please leave your pool equipment such as rails, ladders, fittings, baskets and etc out by the pool.

**Fill your pool** by placing a hose under the cover. **Solid Covers: fill to the middle of the tile. Mesh Covers: fill to the top of the tile.**

Be sure to remove all standing water and leaves from your cover. Additional charges of \$125 per hr will be added if you fail to meet these requirements. Covers will be stored on your property. Can be stored at our facility for \$200 includes extra cleaning and inspection.

**\*Heaters:** We will attempt to start up the heater only if the unit is in good condition and installed properly. If it fails to start an additional service call will be required.

**Pool Closings:** Rockwater Pools LLC will not be responsible for damage to or displacement of covers, pillows, step wedges, plumbing, equipment and etc affected by weather conditions including but not limited to wind, rain, snow or ice.

**Payment Requirements:** the required deposit is due prior to service. Balances are due as specified. 1.5% interest per month will be added to any outstanding balances after 30 days.
