Everything you need for an enjoyable summer by the pool!

**Includes...**

- **Early Spring Prep Service:** Starting in March we will check and start the equipment to inspect for any repairs needed. We will also balance the water chemistry add spring start-up chemicals .
- **Full Service Opening,** winter cover cleaning and inspection / minor repairs.
- **Vacuum** using "Hammer Head" equipment , Brush and Skim as needed.
- **Thorough water analysis using Taylor chemical testing systems and chemistry adjustment.**
- **All balancing chemicals, stain preventer, algacide, salt or sanitizer as needed.**
- **3 General service calls for equipment repairs or maintenance.**
- **\$250 Allowance** for general parts and supplies such as... gauges, o-rings, seals, filter grids, wall return fittings, skimmer baskets - weirs - lids, pump seals, tile repair, temp sensors, and other general parts.
- **Full Service Closing** and winter cover Inspection / minor repairs.
- **Winter Watch Service:** up to 3 visits to check water level and equipment as needed.

**Signature Pool Care Packages Terms and Conditions**

1. Rockwater Pools LLC is under no obligation to continue weekly swimming pool care on accounts which are more than 30 days past due .
2. If the client's pool is subject to excessive foliage, we trust that the client will empty the skimmer baskets regularly.
3. In the event of unforeseen circumstances , such as storms, mud slides, staining and etc., additional charges for chemicals and labor will be added.
4. \*A value of \$250.00 is included for minor replacement parts and accessories. Any additional parts, accessories, and equipment will be extra at a 10% discount .
5. \*\*Service Calls include up to 1 Hr per visit. Can be used for repairs, extra cleanings or maintenance. Plan Includes up to 3 if needed.
6. Spring prep service includes the addition of spring chemicals and equipment startup for inspection. In some cases we will allow the filter system to run on a low setting. This helps prevent spring time algae issues and pollen buildup.
7. Our Commercial Sanitizer Feeder may be used on your pool if needed. This system is the property of Rockwater Pools LLC and is offered free of charge on a leased basis.
8. Rockwater Pools LLC will not be responsible for damage to or displacement of covers , pillows, step wedges , plumbing/ equipment, etc. affected by weather conditions including, but not limited to, wind, rain, snow and /or ice. Winter Watch Plan includes up to 3 Visits to adjust pool cover and check and adjust water level as needed.

**Payment Requirements:** a deposit is due prior to service. Balances are due as specified. 1.5% interest per month is added to outstanding balances after 30 days.

**1/3 Deposit by 4/1/17**

**1/3 Payment by due 7/15/17**

**Final payment due by 9/15/17**
